Pine Acres Golf Course MEMBERSHIP AGREEMENT

This Agreement is made and entered into between the Pine Acres Golf Course, hereinafter referred to as the "Club", and _____, hereinafter referred to as "Member." In consideration of the mutual covenants contained herein, it is hereby agreed by and between each of the parties hereto as follows:

1. Acceptance of Members: The Club may establish criteria for the acceptance of members, which shall include the following:
 - a. Actual acceptance by the Club, and the Club reserves the right to accept a potential applicant.
 - b. Once this Agreement is completed, each Member agrees to be bound by the terms of this Agreement and all Club rules and regulations now in existence or as amended or established by the Club hereafter.
2. Annual Membership: A membership fee is required to become of member of the Club. Memberships are for 1 golf season starting in March (upon payment of the membership fee) and concluding in December in the same calendar year. In addition, the Club may, at times, offer special rates for annual memberships. The Club reserves the right, and has sole discretion, to increase, decrease, change or modify the annual membership fee, including but not limited to, any initiation fee, cart fee, locker fee and range fees.
3. Use of the Clubhouse and Golf Course: The Member shall be entitled to enjoy all privileges of use of the clubhouse and golf course subject to the restrictions contained in this Agreement and any Club Rules and Regulations.
4. Default: The Member shall be in default of the Agreement if any of the following shall occur:

- a. The Member violates any of the Club Rules, Alcohol Policies and Regulations, codes of conduct or dress code.
- b. Violation of the Alcohol Policy, where the use of alcoholic beverages on the golf course, which are not purchased from Pine Acres is strictly prohibited. The first violation of this policy is a written warning. The second violation will result in a suspension of club privileges for 1 month. A third violation will result in a termination of club privileges for 1 year. The consumption of alcoholic beverages by minors will result in an immediate loss of course privileges for 1 year.
5. Remedies in Case of Default: In the event of default of this agreement by the Member, the Club shall have the option to either suspend or revoke the Member's membership and all rights and privileges of the Club with no refund of any amount previously paid by the Member. The club also retains the right to pursue any additional remedy available in law or equity. The Member hereby agrees that no form of notice of default shall be required if the nature of the default relates to any violation of the Club Rules and Regulations.
6. Availability of Facilities: The Club reserves the right to host special events and golf tournaments. Such events may restrict the availability of golf course starting times and any or all Club facilities, including but not limited to, use of the clubhouse, practice range and the golf course itself. The Club shall have no liability for temporary suspension of any privilege due to maintenance, repair, construction, improvements, acts of God, inclement weather, utility disruptions, or any and all matters beyond control of the Club.
7. Assignment: The Member's rights, privileges, or interest under this Agreement are not assignable or transferable. However, the Club may assign its interest in this Agreement, and the liability of the assignor shall be terminated as to events occurring after assignment.
8. Acknowledgement of Bylaws and Rules and Regulations: The Member acknowledges the Bylaws and Rules and Regulations provide the details of the Club's membership policies, conduct and Member obligations.

IN WITNESS WHEREOF, the parties hereto have caused this agreement to be duly executed on the day and year written below. The applicant acknowledges that he/she has read this agreement and agrees to all terms contained herein. Applicant further agrees to abide by this Membership Application and the Club Rules as set forth by the Pine Acres Golf Club.
